

Overview


This document presents a comprehensive implementation review of the administration of the Executive Governor of Kano State, His Excellency Alhaji Abba Kabir Yusuf, covering his second year in office from June 2023 to June 2025. The report assesses 16 key sectors, detailing campaign promises, projects executed, their status (completed, ongoing, or planned), and a calculated weighted score that reflects the level of delivery and impact.

Overall Highlights

- Out of 232 total promises tracked, 161 have been completed, 38 are ongoing, and 33 are in the planning phase, resulting in an overall weighted score of about 81.1%.
- Sectors such as Human Capital Development (100%), Revenue Generation (95.5%), Civil Service and Local Government Reforms (95.3%), Health (94.6%), and Environment (93.8%) recorded the highest delivery rates.
- Key focus areas included education, health, infrastructure, agriculture, youth empowerment, environmental reform, governance transparency, and institutional restructuring.



Achievements



The sectors below show a strong fulfillment of promises with high weighted scores (above 80%).

1] Human Capital Development (100.0%)

All 7 promises have been fully completed — the only sector with a perfect score. This suggests high efficiency and prioritization in this area.

2] Revenue Generation (95.5%)

10 out of 11 promises have been completed. Strong performance here may indicate improved fiscal responsibility or successful internal revenue strategies.

3] Civil Service and Local Government Reforms (95.3%)

Reform-oriented sectors often lag, but this one shows significant progress — 15 of 16 projects completed, indicating administrative efficiency.

4] Health (94.6%)

26 out of 28 promises completed. This strong score reflects serious attention to healthcare delivery due to pressing public health needs.

5] Environment (93.8%)

11 of 12 completed. A commendable result reflecting climate or sanitation efforts.

6] Infrastructure (83.9%)

10 of 14 campaign promises have been completed, with 4 either ongoing or planned. While progress is strong, the remaining projects highlight areas that still need attention to fully realize infrastructure goals.

7] Security (83.9%)

Reasonably high performance with 10 out of 14 completed. This suggests that security issues are being tackled but not fully resolved.

8] Energy and Power (83.3%)

Though only 3 projects were promised, 2 were completed and 1 is ongoing. The score suggests meaningful execution despite the sector's small size.

9] Governance (80.0%)

11 out of 15 completed — a sign of institutional strengthening, transparency initiatives, and administrative reforms.

These sectors are mid-level performers that are making progress but still show room for improvement:

10] Agriculture (75.9%)

With 18 completed and 10 in progress or planned, this shows strategic engagement — but delivery may be staggered.

11] Water Resources (73.2%)

8 completed and 6 ongoing/planned. Access to water often requires longer timelines, which could explain moderate progress.

12] Education (72.3%)

The largest sector in terms of commitments (37), with 19 completed. While more than half are completed or ongoing, the weighted score shows moderate success — a sign of effort but also scale-related challenges.

13] Housing (70.0%)

2 out of 5 completed; a small but active sector.

14] Youth and Sports Development (68.8%)

Mixed outcomes — 6 completed, 3 ongoing, 3 still in planning. Potentially affected by budget prioritization or implementation hurdles.

15] Commerce and Industry (65.9%)

5 out of 11 completed. Investment and industrial policies may be slower due to economic or partnership factors.

Sectors identified as low performers have shown poor or limited progress, necessitating urgent attention, thus:

16] Transportation (50.0%)

This is the weakest performer: only 1 completed, 2 ongoing, and 2 planned out of 5 promises. This could point to funding issues, complex logistics, or underprioritization.

Recommendations

- 1. **Fast-Track Transportation & Infrastructure**: Mobilize funds and partnerships to resolve delays in these foundational sectors.
- 2. **Strengthen Project Monitoring**: Especially in mid-level sectors like Youth Development and Commerce, to ensure ongoing projects are completed.
- 3. **Maintain Momentum in High-Performing Areas**: Prevent complacency and use success stories as benchmarks for lagging sectors.
- 4. **Reevaluate Planned Projects**: For sectors with many "planned" initiatives, reassess feasibility, funding, and timeline alignment.

The review reflects a data-driven, transparent, and citizen-focused approach to governance. It not only benchmarks achievements against campaign promises but also provides a roadmap for further implementation and improvement. The administration's commitment to participatory development, fiscal discipline, service delivery, and infrastructure modernization is clearly evidenced in this second-year performance report.

The performance review across the four thematic areas shows that Access & Equity leads with a high completion rate and a weighted score of 83.9%, indicating strong implementation. Quality & Standards and Tertiary Education show moderate progress, with weighted scores of 68.8% and 62.5% respectively, reflecting a mix of completed and ongoing projects. However, System Strengthening shows modest progress with 1 completed project, 1 ongoing, and 1 still planned, achieving a weighted score of 58.3%, which reflects the need for stronger execution. Overall, out of 37 total promises, 19 have been completed, 13 are ongoing, and 5 are planned, resulting in a respectable average weighted score of 72.3%, though notable gaps remain and require targeted attention.

The health sector shows an impressive overall performance, with a 91.1% weighted score, reflecting high implementation efficiency and commitment. Healthcare System Strengthening achieved a perfect score of 100.0%, with all 8 promised projects completed—indicating a strong focus on improving infrastructure, governance, and institutional frameworks in the health system. Similarly, Health Financing & Investment and Workforce Development each recorded 100.0%, with all planned projects completed. This demonstrates successful efforts in mobilizing resources and building a skilled healthcare workforce. Healthcare Quality & Capacity, while still performing well with a 87.5% score, had 10 out of 12 projects completed, 0 ongoing, and 2 planned—suggesting that efforts to enhance service delivery and facility standards are progressing but not yet fully realized. Overall, with 26 out of 28 health-related promises already completed and only a few remaining planned, the sector reflects exceptional progress and prioritization.

The agricultural sector records an overall weighted score of 75.9% across 28 promises: 18 completed, 3 ongoing, and 7 planned. Agricultural Inputs & Technology and Agricultural Production & Value Chain each scored 79.2% (4 of 6 promises completed), highlighting strong progress in modern inputs, technology adoption, and strengthening of value-chain initiatives. Irrigation & Land Management achieved a higher score of 87.5%, with 3 of 4 projects completed and 1 ongoing, reflecting significant advances in land and water systems. Support Services & Financing stands at 70.0% (3 of 5 completed), showing steady efforts in financial and institutional support to farmers. Livestock & Wildlife lags with 62.5%, as only 3 of 6 promises have been completed while the remaining 3 are still planned. Climate & Environment achieved a perfect score of 100.0% with its single project completed. Overall, the sector demonstrates strong momentum, though livestock and support services require further prioritization to ensure balanced progress across all sub-sectors.

This suggests that while half of the initiatives have been delivered, the other half are yet to be finalized or even initiated. Youth Development & Empowerment performs equally well with a score of 68.8% as well, having completed 2 out of 4 projects, with one ongoing and one planned—indicating a fair level of progress in supporting youth-focused programs. Overall, while the sector has made some strides, especially in empowerment, a significant portion of the initiatives remain incomplete, and accelerated efforts are needed to fully realize the commitments made to youth and sports development.

The commerce and industry sector demonstrates moderate overall performance, with a weighted score of 65.9%, indicating a fair level of implementation but also revealing areas needing further attention. Investment Promotion, MSME Development, and Technology & Infrastructure each recorded a solid score of 75.0%, reflecting meaningful progress with most promises either completed or partially underway—an encouraging sign for enterprise growth and innovation. However, Financial Inclusion & Business Support lags with a low score of 37.5%, as only one project is ongoing and the other still planned, showing minimal advancement in extending financial access and business services to underserved groups. Similarly, Business Environment scored just 50.0%, with its sole project still ongoing and none completed. This suggests a need for greater focus on creating a more enabling and efficient climate for private sector activity. Overall, while the sector has seen notable progress in key areas, increased urgency is needed in delivering on commitments that directly support small businesses, financial inclusion, and regulatory improvements.

However, Planning & Development and Partnerships Performance Management both recorded low scores of 25.0%, with their respective promises still in the planning phase and no implementation yet highlighting significant delays in strategic coordination and inter-agency collaboration. Transparency & Communication posted a moderate 62.5%, with one project completed and one still planned, suggesting partial progress in improving public access to information. Despite the presence of unexecuted projects in a few areas, the sector stands out for its firm delivery in core institutional reforms, making it a strong pillar in the broader governance agenda.
